

# CITY COUNCIL MINUTES CITY OF MAYFIELD, KENTUCKY

March 9, 2020

The City Council of the City of Mayfield, Kentucky, met on Monday, March 9, 2020 at 6:00 p.m. at City Hall, Mayfield, Kentucky. There were present Mayor Kathy S O'Nan, Fire Chief, Ambulance Director & Community Development Coordinator, Jeremy Creason, Police Chief Nathan Kent, Public Works Director Russ Brower, City Attorney Bo Neely, and City Clerk Tamie Johnson.

Police Chief, Nathan Kent, opened the city council meeting.

Councilmember Barry McDonald led the council in prayer.

Councilmember Johnny Jackson led the council in the pledge to the American flag.

Councilmember Chuck Whitnell arrived at 6:01

Liam Sullivan, a 2<sup>nd</sup> grade student at Northside Baptist Christian School, recited the United States Presidents to the council and those in attendance.

On a motion by Cox, seconded by McDonald and with Herndon, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Todd, Adams and Rodgers voting yea, and with none voting nay, Council approved the minutes of the February 10, 2020 meeting. Motion passed unanimously.

## NEW BUSINESS

On a motion made by Jackson, seconded by Rodgers, with Herndon, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Adams, Todd and Rodgers voting yea and none voting nay, Council approved on second reading **Ordinance 1-20**, "an ordinance of the City of Mayfield to rezone 1038 N 15<sup>th</sup> St, Mayfield Kentucky 42066 from R-1 residential single-family zone to M-1 municipal special district zone, and to rezone a building and lot on 1000 block North 15<sup>th</sup> Street extended, Mayfield Kentucky 42066 from B-1 highway commercial to M-1 municipal special district zone." Motion passed unanimously.

On a motion made by Cox, seconded by Parrott, with Rodgers, Todd, Adams, Jackson, McDonald, Whitnell, Myers, Cox, Parrott and Herndon voting yea and with none voting nay, Council approved on second reading **Fiscal Ordinance 3-19**, an ordinance amending Fiscal Ordinance 2-19 adopting the annual budget and scheduled salaries for the City of Mayfield Kentucky for the fiscal year July 1, 2019 through June 30, 2020. estimating revenues and resources and appropriating funds for the operation of city government. Motion passed unanimously.

On a motion made by Rodgers, seconded by Jackson with Herndon, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Adams, Todd and Rodgers voting yea and with none voting nay, Council approved on first reading **Ordinance 2-20**, "an ordinance amending Ordinance 3-19 'limitations of wastewater strength.'" Motion passed unanimously.

On a motion made by McDonald, seconded by Myers, with Rodgers, Todd, Adams, Jackson, McDonald, Whitnell, Myers, Cox, Parrott and Herndon voting yea and with none voting nay, Council voted to enter into executive session per KRS 61.810(1)(c) to discuss proposed or pending litigation against or on behalf of the public agency. Motion passed unanimously.

On a motion made by McDonald, seconded by Myers, with Herndon, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Adams,

Todd and Rodgers voting yea and with none voting nay, Council returned to regular session. Motion passed unanimously. No action was taken in executive session.

Monthly reports were given by department heads and councilmembers.

With no further business to come before the Council, the meeting was adjourned at 6:47 p.m.
