

CITY COUNCIL MINUTES CITY OF MAYFIELD, KENTUCKY

April 10, 2023

The City Council of the City of Mayfield, Kentucky, met in a regular meeting on April 10, 2023, at 5:01 p.m. at the Purchase Area Development District. There were present Mayor Kathy O’Nan, City Attorney Jay Matheny, Police Chief Nathan Kent, Fire Chief, Ambulance Director & Community Development Coordinator Jeremy Creason, Public Works Director Russ Brower and City Clerk Karen Wilson.

Police Chief Nathan Kent opened the city council meeting.

Councilmember Derrick Parrott led the council in prayer.

Councilmember John Poole led the council in the pledge to the American flag.

Chief Nathan Kent recognized Officer Cody Rogers as the recipient of the DUI and Occupant Protection Award from the Kentucky Department of Highway Safety. He also recognized Officer Justin Copelend as the CIT Officer of the Year for the Four Rivers Area.

Mayor Kathy O’Nan read a proclamation declaring April to be Child Abuse Prevention Month. April is also Sexual Abuse Prevention Month. Kelly Cox from CASA presented an overview of the purpose and goals of CASA. Lori Brown from Lotus announced that they would be opening a satellite office in Mayfield this year.

Councilmember Nate Cox arrived at 5:15.

Jason Lemle gave the council an update on the Mayfield Industrial Board.

Stephen Boyken requested that the council help expedite the rezoning of a property located between N 12th Street and N 13th Street in Mayfield. On this four-acre block, Hope Initiative plans to construct sixteen houses.

On a motion by Adams, and seconded by Rodgers, with Carrico, Poole, Adams, Rodgers, Whitnell, McDonald, Jackson, Cox, Parrott and Carr voting yea, and none voting nay, council approved the minutes from the March 13th, 2023, council meeting. Motion passed unanimously.

OLD BUSINESS

On a motion by Jackson, seconded by Cox, with Carrico, Poole, Adams, Rodgers, Whitnell, McDonald, Jackson, Cox, Parrott and Carr voting yea, and none voting nay, council approved on second reading **Ordinance 3-23** an ordinance rezoning certain real property within the City of Mayfield from “I-1 Light Industrial” to “R-2 Multi-Family Residential.” Motion passed unanimously.

NEW BUSINESS

On a motion by Cox, seconded by Carrico, with Carr, Parrott, Cox, Jackson, McDonald, Whitnell, Rodgers, Adams and Poole and Carrico voting yea, and with none voting nay, council approved on first reading **Municipal Order 5-23** “a municipal order authorizing the City of Mayfield, Kentucky to accept and hold title to the real property located at the corner of West Water Street and Ninth Street in Mayfield, Graves County, Kentucky (parcel ID# 205.00.05.001.00) and to

allow the construction of a structure on the above-referenced real property for the use as a farmer's market." Motion passed unanimously.

Department heads gave their reports.

With no further business to come before the Council, the meeting was adjourned at 6:14 p.m.
