September 9, 2019

The City Council of the City of Mayfield, Kentucky, met on Monday, September 9, 2019 at 6:00 p.m. at City Hall, Mayfield, Kentucky. Rita Ray, 1007 Weda Circle, Mayfield KY addressed the council concerning the alcohol ordinance as well as the overgrown area in her neighborhood. The area of concern is involved in a lawsuit and cannot be corrected until the case has been closed.

Council member Chuck Witnell arrived at 6:23 pm.

On a motion by Myers, seconded by Jackson, and with Summers, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Todd and Rodgers voting yea, and with none voting nay, Council approved the minutes of the June 10 and August 12, 2019 meeting. Motion passed unanimously. The June minutes had previously been passed incomplete.

### OLD BUSINESS

On a motion made by Cox, seconded by McDonald, with Summers, Parrott, Cox, Myers, McDonald, Jackson, Todd and Rodgers voting yea and with Whitnell voting nay, Council approved on second reading **Ordinance 4-19**, "an ordinance of the City of Mayfield, Kentucky adopting with amendments found herein to ordinance 24-16 and rescinding ordinance 37-17 accordingly." Motion passed eight to one.

On a motion made by McDonald, seconded by Rodgers, with Rodgers, Todd, Jackson, McDonald, Whitnell, Myers, Cox, Parrott and Summers voting yea and with none voting nay, Council approved on second reading **Ordinance 5-19**, "an ordinance amending ordinance 43-16, chapter 13, planning & development, section 401, by updating schedule of fees and adopting the state of Kentucky's building permit fees." Motion passed unanimously.

### NEW BUSINESS

On a motion made by Jackson, seconded by Parrott, with Summers, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Todd and Rodgers, voting and with none voting nay, Council approved **Fiscal Ordinance 4-19**, "an ordinance levying an ad valorem tax upon all property in the City of Mayfield, Kentucky, as applied to the 2019 assessment of taxable property as provided by the property valuation administrator of Graves County." Motion passed unanimously.

On a motion made by Summers, seconded by Cox, with Rodgers, Todd, Jackson, McDonald, Whitnell, Myers, Cox, Parrott and Summers, voting yea and with none voting nay, Council approved **Resolution 9-1-19**, "a resolution declaring property as surplus." Motion passed unanimously.

On a motion made by Cox, seconded by Jackson, with Summers, Parrott, Cox, Myers, Whitnell, McDonald, Jackson, Todd and Rodgers voting yea and with none voting nay, Council approved **Resolution 9-2-19**, "a resolution allowing the sale of 724 E South St to a citizen." Motion passed unanimously.

Mayor O'Nan presented Councilmember Derrick Parrott with a key to the city to present to his newborn daughter, Arie Ywonne Parrott.

Monthly reports were given by department heads and councilmembers.

With no further business to come before the Council, the meeting was adjourned at 8:02 p.m.
