The City Council of the City of Mayfield, Kentucky, met in a special meeting on December 6, 2023, at 5:01 p.m. at the Purchase Area Development District. On a motion by Carr, seconded by Rodgers, with all those present saying aye and with none saying nay, council approved **Resolution 12-1-23** a resolution “authorizing the support of Murray State University’s Hudson School of Agriculture, School of Veterinary Medicine proposal.” Motion passed unanimously.

On a motion by McDonald, seconded by Cox, with all those present saying aye and with none saying nay, council approved moved to enter into executive session pursuant to KRS 61.810(1)(b) to deliberate on the future acquisition or sale of real property by a public agency when publicity would be likely to affect the value of a specific piece of property to be acquired for public use or sold by a public agency. Motion passed unanimously.

At 6:32 p.m. on a motion by McDonald, seconded by Rodgers, with all present saying aye and with none saying nay, council approved to exit executive session. Motion passed unanimously.

On a motion by Cox, seconded by Parrott, with all those present saying aye and with none saying nay, council approved a motion to authorize Jason Lemle on behalf of the Mayfield, Kentucky Industrial Authority Board to pursue an option agreement on real property within the proposed development area. Motion passed unanimously.
